## Face the Truth Tours

Your support enabled us to sponsor our **Sixth Annual Maryland Face the Truth Tour** headed so capably by **Chrissy Walsh**, Christendon College's 2006 valedictorian. It was one of our very best! Our **Core Team**, mostly college students whom Chrissy recruited, was absolutely the best ever! During our 5-day tour, tens of thousands of motorists saw the ugly face of abortion, many for the first time ever. Some of the pro-life heroes who joined us included **Father Peter West, Paul Schenck, Father Tom Eutenauer, Eric Scheidler, Gerry Mitchell, and Supreme Court lawyer Colette Wilson**. Colette is spearheading an effort to drag pro-aborts **Bill and Hillary Clinton** into court for **campaign fundraising fraud**. One of our financially blessed core team members was so impressed with Colette's efforts that he made a large matching grant to the U.S. Justice Foundation for whom she works. It's a great example of **how life begets life**. In this case, one great pro-life event helped support another great effort!

## GAP (Genocidal Awareness Project)

We own a great set of 12 large **GAP** banners because of your past generosity. These large banners help persons **connect the dots** between the abortion holocaust, slavery, the Nazi holocaust, and numerous other

This year we used this great set of banners on 18 different occasions, 16 of those occasions were on Friday afternoons in Washington, DC. On 4 occasions we were on the Mall by the **Smithsonian Metro Stop** talking mostly to tourists. The other 12 occasions were at **Farragut Square** or **DuPont Circle** in the heart of the Washington business-legal-financial-lobbying corridor. Tens or thousands saw our banners – some such as a black international lawyer who worked on “K” Street – realized what abortion really was for the first time in his life! I’ll never forget overhearing him saying to a friend on his cell phone, *You’ve got to get over here to 16th and K right now.
