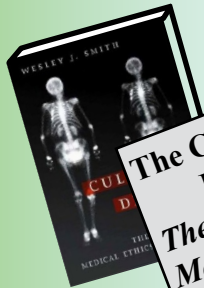
## DEFEATING PAS Physician Assisted Suicide in Maryland

Wesley Smith has authored or co-authored **14** books. He practiced law in the San Fernando Valley from 1976-1985, at which time he left law practice to pursue other interests, particularly as a public policy advocate. His first book in 1987, *The Lawyer Book: A Nuts and Bolts Guide to Client Survival*, introduced by consumer advocate **Ralph Nader**, began a collaboration between the two men. Smith is a prolific author and a frequent contributor to **National Review**. He closely followed the **Terri Schiavo** case in 2005.

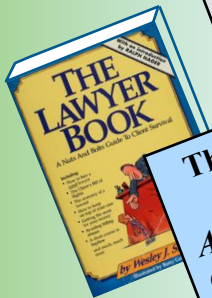
He opposes policies allowing assisted suicide, euthanasia and human cloning. He is also a noted critic of mainstream views in bioethics, human cloning research and radical environmentalism. His book *Culture of Death: The Assault on Medical Ethics in America* was named **Best Health Book of the Year** at the *2001 Independent Publishers Book Awards*.

Smith is a frequent guest on radio and television talk shows, having appeared on national programs such as **Good Morning America** and **Nightline**, as well as internationally on **BBC Radio**.

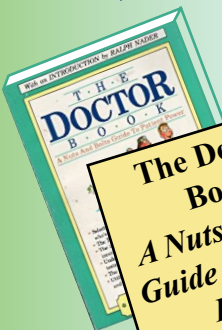
